



Panui No. 20 MAHAKI MANGATU RATIFICATION

Tena koutou katoa ki nga Whanau o te Kaporeihana o Mangatu

An Update on the Recent Mahaki Forest Settlement Claim

Te Aitanga a Mahaki beneficiaries (Mahaki), Mangatu Blocks Incorporation owners (Mangatu) and Wi Pere Trust Board owners (Wi Pere) have been busy participating in the Mahaki Forest Settlement Mandating Process that opened 1 August 2020 and closed at 12 pm Monday 31 August 2020.

Voters were asked to declare their affiliation to up to three options relevant to this settlement.

1,374 voters indicated that they belonged to Te Aitanga a Mahaki.

446 voters indicated that they belonged to Te Whanau a Kai.

232 voters indicated that they belonged to Nga Uri o Tamanui.

A substantial majority, ranging from 94% to 99% of those who voted, supported the six resolutions sought by the United Mahaki Mandating Process.

Mahaki, Mangatu and Wi Pere Voters

The Mahaki voting process is being extended to 31 October 2020 to align with the voting processes being undertaken by Te Whanau a Kai and Nga Uri o Tamanui claimant groups.

If you have not voted we encourage you to do so as we need your vote.

We recommend you register first, preferably online via www.mahaki.com. Once registered with Mahaki you will need to vote before 31 October 2020.

We recommend that you vote in favour of the six United Mahaki Mandate resolutions.

Te Whanau a Kai Voters.

For those voters who identified as Te Whanau a Kai you will need to register with the Te Whanau a Kai Trust. If you have not registered with the Te Whanau a Kai Trust please register as soon as possible, preferably online via www.tewhanauakai.com.

Once registered with the Te Whanau a Kai Trust, you will need to vote before 31 October 2020.

We recommend you vote against the Te Whanau a Kai Trust mandate. This is important to validate your support, as Te Whanau a Kai, for the United Mahaki Mandate



Nga Uri o Tamanui Voters

For those voters who identified as Nga Uri o Tamanui (NUOT) you need to register with the NUOT Trust, preferably online via www.nuot.co.nz. If you have not registered with the NUOT Trust please register as soon as possible.

Nga Uri o Tamanui will be running a three-step process;

1. Register yourself with the NUOT Trust.
2. Nominate trustees to the Trust by 8 October 2020.
3. Vote for the NUOT Entity with the trustees in place by 13 November 2020.

Once registered with the NUOT Trust, you will need to vote before 31 October 2020.

We recommend you vote against the mandate for the NUOT Trust. This is important to validate your support, as Nga Uri o Tamanui, for the United Mahaki Mandate

Concluding Comments

There is still a lot of work to be done to achieve a United Mahaki Settlement. We need your help. This is the final shot that we will have and we need to make it count.
